LOCATION: This property is located on Pleasant Ridge Road, approximately 4 miles from Olla. It is located in Section 8, T10N, R3E, LaSalle Parish, Louisiana.

DESCRIPTION: As shown on the enclosed maps, both the 35.6-acre parcel and the 43.8-acre parcel have approximately one-quarter mile of parish road frontage. With both upland ground and creek bottom, this property has excellent potential for rural homesites as well as hunting, and timber production.

TOPOGRAPHY & SOILS: Tarver Creek runs through both tracts. Upland areas are on the south end, along the road, with the creek and bottomland areas mostly in the central portions. The USDA Soil Survey indicates that the soils in the upland areas are silt loam and the bottomland areas have Guyton and Ouachita soils.

TIMBER: Most upland areas are predominately pine and the bottoms have nice stands of hardwood. Estimated timber volumes are provided on page 3.

UTILITIES: Electricity is currently available and community water is believed to be available to the west and east of these tracts. To confirm availability for your intended use we recommend contacting the providers (Entergy and Pleasant Ridge Water System).

MINERALS: This property is offered for sale with the seller conveying all of the mineral rights (oil, gas and associated hydrocarbons). <u>100% will transfer to the buyer</u>.

DIRECTIONS: From the intersection of LA Highway 127 and Pleasant Ridge Road, approximately 4 miles out of Olla, travel approximately 1.8 miles to the intersection of Pleasant Ridge and Mixon Road. Turn right and continue on Pleasant Ridge Road approximately 1/10 mile to the west line of Tract A.
